**General Meeting**  
**May 17, 2014**

The general meeting was called to order at 9:30am by Vicki Graham. There was one new member and two visitors. Vicki announced upcoming quilt shows and their information is at the Bulletin Board.

The general meeting minutes from March 2014 were approved as printed in the newsletter on a motion by Liz Adams, seconded by Bonnie Spoon.

The Treasurer's Report had an ending balance of \$9101.88. The report was filed as reported and will be on the website.

President Elect: Molly announced her nominating committee. Openings needed are President-Elect and Treasurer.

Program Coordinator #1: Lori Schrock announced that July's program speaker and workshop will be Deborah Schupp. Today's speaker will be Marty Moon. Marty gave a Friday workshop on dyeing fabric.

Ways and Means: Karen has a raffle and door prizes for today. If anyone needs quilt raffle tickets, please see Karen.

Service: Denise has 30 quilts ready for the Winchester group as well as quilts for hospice.

Sunshine: Sue sent 3 birthday cards and 5 TOY blocks.

Old Business: The suggested changes to the by-laws have been on the website since June 2013. Since some members do not have access to the web, the updated by-laws will be printed in the newsletter and be voted on at the June 2014 meeting.

Quilt Show Update: Lori Abbott-Herrick and Fran Miller updated us on the quilt show. Today is the deadline to show entries. As a reminder, quilts with a width of greater than 48 inches will need a 4 inch deep sleeve. Electronic payments will be available at the show for the boutique. We have one month to finish pillows for the pillow puddle. There are changes as to how the pillow puddle works; a winner will be able to pick the pillow they want. Voting for the quilts will be counted on Saturday and the winning quilts will have their ribbons attached. Volunteers who work at the show for two hours, entry is free. Anyone who wants to support the show and the program booklet can be a patron. To have your name listed, the deadline is June 1<sup>st</sup>. There will be a children's room with scheduled reading time, coloring muslin blocks, watching gems made into spheres and a Sudoku quilt to play with. They will be stuffing dog pillows that will be donated to area animal shelters. There are postcards and flyers available to deliver to shops if you can help with this. Be prepared to wait to pick up your quilts following the closing of the show. It takes a while to take everything down. If anyone can prepare a slide presentation of Bill and Sue, please see one of the show chairs. An added feature is scissor sharpening. Bring your scissors, no pinking shears, and they will be sharpened while you are at the show.

A half dozen members spent an enjoyable Friday afternoon with Marty Moon learning about Shibori dyeing and getting to dye their own pieces. Marty brought a multitude of exquisite samples for us to see. Then we carefully wrapped, folded and tied our fabrics together before the plunge (the fabrics) into the dye. After the fabrics came out of the dye they went straight into the microwave oven for a quick blast of heat to set the dye. All of us ended up some really neat pieces to include in future projects.

On Saturday morning Marty gave us lots of unique ideas for projects that we can use up our leftover blocks, strips and other assorted pieces. Marty showed many examples of chopping up blocks and reassembling them with other pieces to get a whole new look. Borders made of chopped up blocks and strips were another creative example Marty shared. I know I am looking forward to using my leftover strips from a quilt I recently made to make placemats. I'm sure my 13 year old son will be putting those placemats to the test soon.

In June the Quilt Show chairs will be doing the program to get us all ready for the upcoming show. Please be sure to thank these ladies who are putting in hours and hours of work to make this show happen.

## **BY-LAWS OF THE SHENANDOAH VALLEY QUILTERS GUILD**

**JUNE 2014**

---

### **Article I – Name and Type of Organization**

The name of this organization is the Shenandoah Valley Quilters Guild, (the “Guild”) which is intended to be an educational, not-for-profit 501(c)(3) corporation, as defined within the meaning of the Internal Revenue Code. The Guild fiscal year begins 1 February through 31 January for tax filing purposes.

### **Article II – Purpose**

The purpose of the Guild shall be to promote the various aspects of the art of quilting, to educate and develop the skill levels of the members, and to make a contribution to the Community, relative to quilt making.

### **Article III – Membership and Dues**

Section 1. Personal Membership in the Guild is open to any person who subscribes to the purpose of this Guild and pays dues. The Guild membership year shall run from 1 April through 31 March.

Section 2. Membership dues. Membership dues shall be determined by the Board of Directors (“Board”), and approved by a majority of the attending members at the June Annual meeting or at any other regular or special meeting of the Guild, with proper notification in the newsletter preceding such meetings.

Section 3. Guests. Guests are welcome to attend one meeting in a membership year. They must pay dues to join on their second visit.

### **Article IV – Officers**

Section 1. Elected Officers. The elected officers are: President, President-Elect, Secretary, Treasurer, First Program/Workshop Coordinator, Second Program/Workshop Coordinator, (from this point on referred to as 1<sup>st</sup> Coordinator, and 2<sup>nd</sup> Coordinator). All officers shall enroll in the National Quilters Association (NQA) as members subsequent to election if they are not already NQA members.

Section 2. Officers shall be elected by a majority of those attending members at the June Annual meeting and shall serve for their term of office commencing after installation at the August meeting.

Section 3. Term of Office. No elected officer shall serve more than five consecutive terms in the same position.

Section 4. Governing Body. A Board of Directors, consisting of the elected officers and the immediate Past President, shall govern the Guild. The elected officers shall be President, President-elect, Secretary, Treasurer, 1<sup>st</sup> Program/Workshop Coordinator, and 2<sup>nd</sup> Program/Workshop Coordinator.

Section 5. Duties of Officers.

- a. President – The President shall preside over the Board and general meetings and be an ex-officio member of all committees. The President, with the approval of the Board, shall appoint successors to fill un-expired terms of members of the Board.
- b. President-Elect – The President-Elect shall preside in the absence of or at the request of the President and perform all duties of the Presidency as required.
- c. Secretary – The Secretary shall record minutes for general meetings and Board meetings, and shall also serve as corresponding secretary. The Secretary shall maintain a copy of the current by-laws.
- d. Treasurer. The Treasurer is the custodian of guild financial assets, maintains receipts and disburses funds as required by guild commitments and objectives as authorized by the Board. The Treasurer maintains appropriate records to effect compliance with state, federal government and guild reporting requirements (cash basis of accounting
- e. Immediate Past President – shall serve in an advisory capacity and shall have voting rights on the Board.
- f. Program/Workshop Coordinators – There are two program Coordinators (1<sup>st</sup> Coordinator and 2<sup>nd</sup> Coordinator) responsible for the guild meeting programs/workshops. These elective offices will be a consecutive two-term position.

## **Article V – Meetings**

Section 1. All meetings of the Guild will be conducted according to the most recent Robert's Rule of Order. A simple majority of the total attending membership at any general or annual meetings shall be sufficient to conduct Guild business.

Section 2. Regular Meetings. General Guild meetings shall be held the third Saturday of each month at 9:30 a.m. Date or time may be changed at the discretion of the Board. Any business requiring a membership vote may be conducted at any general meeting, with the exception of the election of officers.

Section 3. Annual Meeting. The annual meeting shall be held in June of each year for the election of officers.

Section 4. Board of Directors Meeting. The elected Board and the immediate Past President shall meet monthly prior to the general Guild meeting, or at any other time as deemed necessary. A quorum for conducting business shall be a simple majority of Board members as defined in Article IV, Section 4. In extenuating circumstances the President may call or email the Board for discussion and/or a vote

## **Article VI – Committees**

Committees shall consist of a Chairperson, appointed by the President, and additional individuals as such Chairpersons may choose to assist them.

Section 1. Nominating Committee. The President-Elect shall chair the Nominating Committee. The committee shall consist of three to five members, including at least one Board member, two Guild members at large, and shall be chosen at the March meeting.

Section 2. Newsletter Committee. The Newsletter Committee shall be responsible for producing a monthly newsletter, with the exception of December.

Section 3. Membership Committee. The Membership Committee shall be responsible for recruiting and orienting new members, providing a welcoming packet, issuing membership cards, and maintaining a membership directory which will be provided to the Newsletter Editor and printed in the May newsletter.

Section 4. Publicity Committee. The Publicity Committee shall submit news articles to publications, and advertise Guild events.

Section 5. Hospitality Committee. The Hospitality Committee shall plan for refreshments and greet attendees for the general meetings or when requested by the Board for special events.

Section 6. Ways and Means Committee. The Ways and Means Committee shall be responsible for planning and overseeing all guild fund raising activities to include the annual auction and the Guild raffle quilt project.

Section 7. Web Site Administration. The Web Site Committee shall be responsible for maintaining the guild's Internet website.

Section 8. Librarian. The Librarian shall maintain the Guild library, obtain and catalog new library books, and coordinate check-in/check-out of materials at general Guild meetings. The Librarian is responsible for the de-accession of materials as needed.

Section 9. Service Projects Committee. The Service Projects Committee shall be responsible for acquiring or purchasing materials to make service projects, setting up work sessions, and taking finished projects to designated recipients.

Section 10. Quilt Show Committee. The Board shall appoint the next Quilt Show Committee Chairperson within three months following the end of each Show.

Section 11. Sunshine Committee. The Sunshine Committee shall be responsible for providing notes and/or thinking-of-you blocks to Guild members who may be in need of physical or emotional support.

Section 12. Special Committees. Special Committees may be appointed by the President or by the Board as deemed necessary.

### **Articles VII – Amendments.**

Bylaw amendments may be proposed by any Guild member to the Board or to the Guild in writing for consideration and review, with a written Board response required. These Bylaws may be amended or repealed, in whole or in part, by a majority vote of the members present at a duly organized meeting of the Guild. All proposed amendments must be reported at a general meeting and published in the Newsletter preceding the meeting at which they are to be voted on.

An ad-hoc committee appointed by the Board shall review the Guild Bylaws every five years.

### **Articles VIII – Dissolution**

Upon dissolution of the Guild, any funds of the organization will be distributed to a non-profit organization, selected by the Board of Directors, which itself is exempt within the meaning of Section 501 (c) 3 of the Internal Revenue Code.

Original bylaws adopted 12/12/1987, Article V adopted 9/16/1990, Article VI, Committee Section 11 adopted May 1994, revised January 2003, revised January 2004, and this revision adopted in its entirety January 2009. Substantial revisions made June 2013: Policy and Procedures section added; Article IV, Section e added; Historian office removed; Article VI, Section 7 added; clarifications to other sections.

### **Dump Cake Recipe -**
